Once completed and checked, Accident/ Incident Reports are filed on the child's Personal Record (red file). The Summary Index is filed in the Accident/ Incident File. The information contained in the Summary Index enables relevant Accident/ Incident Reports to be quickly sourced by cross referencing the index number, date and child's name.
