Article 36 Where any institution engaged in family planning technical services, in violation of the provisions of these Regulations, expands its family planning technical service items without approval, the original certificate-issuing authority shall order it to make corrections, give a warning and confiscate its illegal income; if its illegal income is not less than 5,000 yuan, a fine of not less than two times but not more than five times the amount of its illegal income shall be ...
