Later, at the Starr grand jury, Clinton stated that he believed the definition of "sexual relations" agreed upon for the Jones deposition excluded his receiving oral sex. Starr’s investigation eventually led to the impeachment of President Clinton, with whom Starr shared Time’s Man of the Year designation for 1998. Despite his impeachment, the president was acquitted in the subsequent trial before the United States Senate as all 45 Democrats and 10 Republicans voted to acquit.
