Residential Mortgage Loan Origination - Statutes and Rules

The SAFE Mortgage Licensing Act is designed to enhance consumer protection and reduce fraud by encouraging states to establish minimum standards for the licensing and registration of state-licensed mortgage loan originators and for the Conference of State Bank Supervisors (CSBS) and the American Association of Residential Mortgage Regulators (AARMR) to establish and maintain a nationwide mortgage licensing system and registry for the residential mortgage industry.

Texas - OCCC Mortgage Originator New Licence Education Requirements. New mortgage loan originators must complete 20 hours of NMLS approved education. This education must include 3 hours of Federal law, 3 hours of ethics and 2 hours of non-traditional mortgage lending, plus 12 hours of undefined education (referred to as electives).

Loan Originator (MLO) licensing process that meets certain standards through the NMLS (Nationwide Mortgage Licensing System & Registry). The Act requires all MLOs seeking state-licensure to pass the NMLS-developed SAFE Mortgage Loan Originator Test with a score of 75% or better.

(c) A residential mortgage loan originator licensed by a regulatory official to engage in business as a mortgage loan originator in this state under a chapter listed in Section 180.051(a)(1) is considered to have temporary authority to act as a residential mortgage loan originator under a different chapter listed in Section 180.051(a)(1) for a ...

Residential Mortgage Loan Originators - Texas

The Texas SAFE Act requires individuals acting as residential mortgage loan originators to be licensed. A residential mortgage loan originator is

defined as an individual who for compensation or gain, or in expectation of compensation or gain, takes a residential mortgage loan application or offers or negotiates the terms of a residential mortgage loan.

Residential Mortgage Loan Origination - Texas

Securing your loan officer license in Texas requires 20 hours of national mortgage education and 3 hours of a state-specific law and rules course for new mortgage loan officers. For previously licensed mortgage loan originators, only the 3-hour state-specific law and rules course is required.
