1. The President of the Russian Federation shall be the head of the State. 2. The President of the Russian Federation shall be guarantor of the Constitution of the Russian Federation, of the rights and freedoms of man and citizen.

The Constitution of the Russian Federation shall have supreme legal force, direct effect and shall be applicable on the entire territory of the Russian Federation. Chapter 5. The Federal Assembly | The Constitution of the ...

1. The listing in the Constitution of the Russian Federation of the fundamental rights and freedoms shall not be interpreted as a rejection or derogation of other universally recognized human rights and freedoms. 2. The 2020 amendments to the Constitution of Russia are proposed amendments to the 1993 Constitution of Russia.Putin spoke about the amendments during his address to the Parliament on 15 January 2020. Putin noted that Russia's parliament is legally capable of changing the Constitution, but he argued that a national vote is necessary to make the amendments legitimate.
